WEEKLY UPDATE

1/29/21

Dear Residents and Families/Representatives,

Please accept this letter as our weekly update regarding the status of COVID-19 in our facility. Since the onset of this virus, we have had 73 residents and 35 staff members test positive for COVID-19. This week we had no new positive residents and 1 new positive staff member. Due to our ongoing high community positivity rate, we continue to be at risk for further outbreaks. We are working with our local and state health departments to implement recommendations to protect our residents and staff.

Due to our current outbreak status, we are not open for visitation. We continue to allow essential caregiver/compassionate care visits per interdisciplinary team recommendations. Please contact our facility for further questions.

As always, we are working hard to keep everyone in our community safe and we will continue to practice the enhanced safety precautions that are known to prevent the spread of COVID-19, such as only essential personnel are allowed inside the facility and we screen them for signs and symptoms of illness prior to entering. Our residents are continually monitored and staff is using PPE as recommended by the CDC. Staff is frequently reminded and encouraged to practice social distancing and to use hand sanitizer and frequently wash their hands when they are in the facility and out in the community. We ask them not to report to work if they have symptoms of illness.
